These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation. Sample Corporate Resolution for Signing Authority ... Specific Authorisation: In some cases, the board of directors can also authorise any director or official of the company to sign a specific agreement with a specific party on a certain case by passing a board resolution. The following is a template of board resolution for authorising an official to sign an agreement. In addition to describing a decision or action that the board wants to take and giving authority to a group or person, a certified board resolution provides proof that the resolution was verified by the board secretary and was approved by the board’s president. Any agency with a board of directors (such as a nonprofit, school district, or hospital) or trustees or any government agency with a decision-making body (such as a city council, town board, or county board of supervisors) needs a resolution to apply for and accept grant funds after an official letter has been received announcing a forthcoming award.
